INTERNATIONAL RELATIONS

Security Studies (BIR182113-3)

[3 Credits]

This course focuses on the efforts of political actors within the international system to overcome all types of threats and fears against their interest. It discusses both traditional and non-traditional threats and serves as an introductory course for Sub-discipline 1, International Politics and Security.

International Political Economy (BIR182213-3)

[3 Credits]

This course discusses the structure of the international political economy, including activities and the main institutions which shape such structures. Moreover, the course will also examine the relationship between economic activities and global politics, as well as give recommendations about Indonesia's strategic position amid the dynamic conditions of the global political economy.

International Communications (BIR18413-3)

[3 Credits]

This course helps students achieve the following competences: knowledge of concepts, actors, contemporary issues, and analytic instruments needed to analyze Indonesia's foreign policy dynamics; responsible and outspoken personalities as well as the willingness to take responsibility for their work and opinions on Indonesia's foreign policy; having empathy and critical thoughts towards the development of Indonesia's foreign policy issues from the Independence Era, Revolution Era, New Order Era, and Reform Era

INTERNATIONAL RELATIONS

International Organizations (BIR18233-3)

[3 Credits]

This course examines the complexity of internal arrangement in international organizations, including the role of actors in influencing policy outcomes of international organizations, the decision-making process and power and wealth distribution in international organizations, the position of an international organization within the global political constellation, and critiques of international organizations. The course equips students with the ability to analyze international organizations using tools of analysis provided by main theories of international relations, which later will help students in differentiating and classifying international organizations based on certain groupings

Indonesian Foreign Policy (BIR183115-3)

[3 Credits]

This course helps students achieve the following competences: knowledge of concepts, actors, contemporary issues, and analytic instruments needed to analyze Indonesia's foreign policy dynamics; responsible and outspoken personalities as well as the willingness to take responsibility for their work and opinions on Indonesia's foreign policy; having empathy and critical thoughts towards the development of Indonesia's foreign policy issues from the Independence Era, Revolution Era, New Order Era, and Reform Era

LAW

The Law of The Sea (LAW184151-02)

[2 Credits]

The course will explore the concept of the law of the sea and its historical development as well as its sources. It will then focus the discussion on the UNCLOS 1982 that has been described as the Constitution of the Ocean. It will see its negotiation process, its achievement as well as its main provisions including the maritime zones, the protection of the marine environment, fisheries management, navigational rights and freedoms, settlement of dispute, and military uses of the oceans. It will also discuss contemporary issues on the subject that might include, the South China Sea issue, the effect of sea-rise to the Coastal State, economical activities in areas beyond national jurisdiction and Indonesian maritime boundaries delimitation process.

Humanitarian Law (LAW184149-02)

[2 Credits]

The course will explore the theoretical scope and practical application of international humanitarian law (IHL), also known as the law of war/armed conflict. It will discuss the history and development of IHL as well as its legal sources and legal framework. It will discuss the main principles of IHL and subsequently consider the application of the principles in action IHL i.e. the qualification of armed conflict, targeting, the notion of direct participation in hostilities. The course will also discuss contemporary issues of IHL, including the mix-nature of armed conflicts, asymmetrical warfare, novel technologies in weaponry, automated weapon system and cyber-attack.

Investment Law (LAW 01172018-01)

[1 Credits]

This course deals with the legal rules and principles governing investment, especially foreign investment, in Indonesia. Attention will be given not only to the application of the law as guidance for investors, but also on government policy and contemporary issues shaping Indonesian investment law. The legal framework explored is both national (Indonesian domestic laws and regulations) as well as international (investment treaties and general international law governing foreign investment).

Labour Law (182118-2)

[2 Credits]

This course will explore employment relationships between workers and employers. This relationship will apply a bipartite mechanism, which is based on agreement between the parties. Nevertheless, since employment relationships in Indonesia economically and socially create inequality between them, there is a tripartite mechanism to balance their relationship. It means that intervention of Indonesian government by issuing mandatory rules to protect the workers makes many aspects in Indonesian Labour Law is beyond the scope of agreement between the parties. A study of the law governing the employment relationship, including the establishment and termination of that relationship. Specific topics studied include employee access to job opportunities, employer information gathering (including testing), problems arising in the relationship between employers and employees organized and represented by labor unions, company regulation and collective labour agreement, prohibited discriminatory employment practices, regulation of wages, hours, and benefits of employment occupational safety and health, and social security protection for workers.

MECHATRONICS

Introduction to Mechatronics (IME 181211-2)

[2 Credits]

The word mechatronics is composed of mecha from mechanics and tronics from electronics. In other words, technologies and developed products will be incorporating electronics more and more into mechanisms, intimately and organically, and making it impossible to tell where one ends and the other begins (T. Mori, "Mechatronics,").

Yet, people also define it differently as follows: Mechatronics is the synergistic integration of sensors, actuators, signal conditioning, power electronics, decision and control algorithms, and computer hardware and software to manage complexity, uncertainty, and communication in engineered systems.

In this course, students will learn about the basic concepts of how mechatronic systems function. It will also discuss the main components of a mechatronic system and how they can be applied in an industry to increase productivity and work safety. In addition, the role of mechatronics in daily life will also be briefly discussed

INDONESIAN CREDIT SYSTEM
